Every year we have young campers who fly to Canada alone under an Unaccompanied Minor status. Most airlines provide this service to assist young children in traveling from their point of departure to their final destination.

We have compiled information from various airlines, that currently fly into Toronto Pearson International Airport, to assist you in planning for your child's travel to camp. This is for your information only and should not be considered an endorsement or recommendation of any particular airline.

Should you decide to purchase this service, you will need the following information: the name of the adult bringing your child to the airport and the adult meeting them at their destination. (Please list Emily Schoelzel, 413-325-7739, Keewaydin Camps, Lake Temagami, Temagami, ON as the receiving adult in Toronto.) Have these names, addresses and phone numbers handy to help expedite the call with your travel agent or reservation agent.

Please complete your child's travel form indicating that he/she is traveling as an Unaccompanied Minor and return to us as soon as travel plans are made. This information is vital to us as we make arrangements to meet campers in Toronto.

If you have any questions about travel to Devil's Island, please call Annette Franklin at 802-352-4709. Annette collects all the travel information for campers and can assist you in the process of making arrangements.

AIR CANADA

What age does my child need to be to use this service?

Mandatory for children age 8-11 who are traveling alone. Optional for children age 12 to 17 traveling alone.

What are the fees associated with this service?

\$100 CAD/USD one way

Are there any flight restrictions?

Unaccompanied Minor Service is available only on non-stop flights operated by Air Canada and Jazz; Tier 3 flights Central Mountain Air (CMA), Air Georgian (GX) and Exploits Valley Air (8k). The service is not available for connecting or codeshare flights.

How do I book this service?

AMERICAN

What age does my child need to be to use this service?

Mandatory for children ages 5-14 traveling without an adult who is at least 16 years old. Optional for children ages 15-17

What are the fees associated with this service?

\$150 each way, plus tax.

The charge will be assessed for each individual unaccompanied minor. Two or more unaccompanied children from the same family, traveling on the same flights, will be assessed a single charge.

Are there any flight restrictions?

Unaccompanied Minors ages 5-14 cannot travel on an itinerary that involves a change of aircraft. Unaccompanied Minors cannot travel on the last on-line connection to any American Airlines, American Eagle or AmericanConnection destination. American Airlines, American Eagle, and AmericanConnection do not accept unaccompanied children when their itinerary includes a connection to/from another airline, including codeshare and one world partners. Some additional restrictions for AmericanConnection flights also apply; contact American Airlines.

DELTA

What age does my child need to be to use this service?

Mandatory for all children 5 -14 years old when not traveling in the same compartment with an adult at least 18 years old or the child's parent/legal guardian.

Available for children age 15-17 if requested.

What are the fees associated with this service?

A **\$100 fee, to be paid at check-in**, is due for one-way travel. Only one \$100 fee will be charged for up to four children traveling together.

Are there any flight restrictions?

Children ages 5 - 7 years can fly on nonstop flights only.

Children ages 8 - 14 years can fly on nonstop or connecting flights, but may only connect to other Delta, Delta Connection (excluding AA Eagle), KLM, and Air France flight. An unaccompanied child cannot be booked on the last connecting flight of the evening. Unaccompanied minors will not be permitted on Red Eye flights, that is, those departing between 9pm and 5am. Exceptions: Domestic short haul flights (2 hours or less, non-stop) , Markets with only one connection and it is the last flight of the day.

UNITED

What age does my child need to be to use this service?

Mandatory for children ages 5-11 traveling without an adult. Optional for children ages 12-17 years

What are the fees associated with this service?

\$99 each way

NOTE: Two or more children who are traveling together will be assessed a single fee in each direction.

Are there any flight restrictions?

Unaccompanied minors may travel only on United flights that are nonstop or direct. (A direct flight makes a stop without a plane change.) May not travel on connecting flights, but may travel on the last nonstop flight of the day.

WESTJET

What age does my child need to be to use this service?

Mandatory service for passengers travelling alone between the ages of 8 and 11. Passengers who have reached their 12th birthday are able to travel on their own.

Optional service for children travelling alone between the ages of 12 and 17.

This program is available for flights flown between two Canadian cities on WestJet aircraft.

What are the fees associated with this service?

A **\$100 USD/CAD fee per direction**, per child will be collected at the time of booking.

Are there any flight restrictions?

Unaccompanied Minors are only allowed on direct and non-stop flights.
